OPERATIONAL HIGHLIGHTS

Sales for the first quarter of F12 increased by \$5.1 million or 3.1% over the same period for F11. Sales volumes increased by 3.4% for spirits and 8.4% for wine and remained flat for coolers/ciders and beer. Net profit increased by \$1.4 million or 2.2%.

Effective April 1, 2011 the MLCC converted to International Financial Reporting Standards on a retrospective basis, as required. Comparative information was restated accordingly.

In May, the province introduced a New Hospitality Strategy designed to modernize Manitoba's liquor laws within a framework of social responsibility. The strategy consists of 38 initiatives under four pillars - new hospitality opportunities, greater public safety and well-being, underage drinking countermeasures, and red tape reduction - and includes changes to *The Liquor Control Act*, its regulations and MLCC policy. The amendments received royal assent on June 16, 2011, with amendments to be phased-in over the next year. To provide Manitobans with more information about the Hospitality Strategy, a stand-alone website has been established at www.mlcchospitality.com.

The MLCC partnered with the Parents Advisory Council of Manitoba to distribute *Be the Influence* information booklets to 300 conference participants. Posters promoting the program to parents were placed in 35 community clubs throughout the province. The 10th Annual Winnipeg Wine Festival was held May 1 - 7, 2011. The festival raised \$272,000 for Special Olympics Manitoba, bringing its 10 year fundraising total to \$2.1 million. A public meeting was held in Gimli in June and included discussion about a new store location.

A lease was signed for space in the Fort Garry Business Centre for office space required to accommodate growth in staff resulting from the ongoing growth in our business. Plans for the first Liquor Mart Express store at the James A. Richardson International Airport are underway and on schedule for an October 30, 2011 opening. An agreement was reached with the Stonewall Liquor Vendor to convert the store to a Liquor Mart. Construction of the Tuxedo Liquor Mart continues. The MLCC continues to work toward LEED® standards in its construction projects.

Portable defibrillators have been installed and staff trained at 28 Liquor Marts. Roll-out of the program will conclude in the 2nd quarter.
